Safety Instructions

This equipment generates pure 99% hydrogen. Hydrogen is a highly flammable gas, if not operated properly it could combust easily. Please, read this safety instructions carefully and make sure to operate the machine accordingly.

I. WARNING:



1.It is strictly prohibited to use this equipment near an open flame, heat, smoke, sparks or any object at high temperature.



2.It is strictly prohibited to use this equipment in a closed environment. Use your machine in well ventilated areas only. It is not advised to use this machine in places with a lot of highly flammable objects eg: bedroom, kitchen.



3. People with serious illness should not use this machine without supervision. Remember to use this machine under your physician's guidance.



4.In order to maintain optimal efficiency, this machine can not be used for more than three consecutive hours. Turn your machine off for one hour every three hours of use.



5. Be sure to leave your machine in a warm environment for at least 12 hours before each use when using it in the winter season.

6.It is strictly prohibited to artificially block the hydrogen and oxygen outlet ports while the machine is operating. Make sure to not over tighten the machine's tank cap.



7. Beware of using the machine in a dry environment. Electrostatic shock may occur.



8. Keep the power adapter away from any water or heat source.



9.Do not inhale hydrogen gas without your physician's permission. Always consult a medical professional for any medical advice.


II. Use conditions:

- 1. Room temperature: 41°F 86°F (5°C-30°C) Room humidity: 25% - 75%
- 2. Power supply voltage: $115/220V \pm 10\%$, $50Hz \pm 10\%$
- 3. Power supply must be grounded. Make sure your home has the proper grounding wiring.
- 4. Use only distilled water with a TDS level of 5 or less.

III. Working Environment:


- 1. Do not store your machine in a room with a temperature bellow 40°F(5°C) to prevent water inside the machine of freezing.
- 2. No smoking near the machine or any other kind of open flame.
- 3. Make sure to follow anti-static measures when using your machine and to keep a clean working environment.

Operation Instructions

Step 1: Make sure that the machine is placed in a well ventilated area bigger than 50sq-ft. Unscrew the tank's cap and pour in distilled water.




Operation Instructions

Step 2: To start, please ensure the water stays above the minimum water level line.



Step 3: Plug in power adapter to a wall plug and insert cannula in the outlet port.



Step 3: Press the On/Off button to turn on the machine. Press the button once for 2 hours of operation. Press it twice for 3 hours of operation. Press it three times to turn it off.

Note: You may also press and hold the On/Off button for 3 seconds or more to turn it off.







Note: You may hear a "beep" if the cannula or diffuser stone is unplugged while the machine is on. You won't hear a "beep" if the tubbing is plugged back in. Do not cover the hydrogen outlet while the machine is on.

Operation Instructions

To inhale hydrogen:

Step 1: Insert hydrogen cannula into the hydrogen outlet port.



To inhale hydrogen and oxygen:

Step 1: Use hydrogen and oxygen cannula to connect the tubbing into the hydrogen and oxygen outlet ports.



To make hydrogen water:

Step 1: Insert stone diffuser into the hydrogen outlet port.



Step 2: Leave stone diffuser inside a water container for at least 15 minutes to infuse 1 liter of water.



Note: The hydrogen water will remain charged for 30 minutes to 1 hour. Drink your hydrogen water preferably immediately after infusing it.

Maintenance

- Please replace the machine's water for every week of use.
- Please drain the machine's tank If you don't plan on using your machine for a week or longer
- If poor quality water is used in the machine the hydrogen output may be reduced, the internal piping could get blocked and the over-all service life of the machine will be shorter. Please use only distilled water.

Tips

- Do not use tap water.
- Do not use purified water or bottled water.
- Do not use sparkling water.
- Failures caused by improper water sources are not covered by the warranty.

| Issue | Possible Cause | Solutions |

| Machine failed to start | Power adapter might be unplugged. The On/Off button has not been pressed. | Make sure the power adapter is plugged to a wall outlet. Press the On/Off button. |
| No hydrogen coming out | Low water level Cannula or stone diffuser not connected properly. Machine failure. | Top off distilled water tank. Make sure to connect cannula or stone diffuser properly. Please contact us. |
| Red Light On | Light flashing slowly Low water level Light flashing red and blue. High TDS detected. Light flashing quickly Machine is tilted. Light constantly on. Machine in cleaning mode. | Add distilled water. Drain water in tank and replace it. Make sure machine sits flat. Turn machine off and turn it back on. |
